One of the mandatory conditions to be eligible for the examination was to submit the domicile certificate showing that the candidate submitting examination form is bonafide domicile of Delhi.

To ensure correctness of the Domicile Certificate, CBSE got the verification done of these Domicile Certificates submitted by these candidates. The concerned issuing authorities have reported that the domicile certificates submitted by the aforesaid candidates have not been issued by them. Hence, the results of these candidates were not declared on 13.05.2024 and



have been placed under **Result Later (RL) category** as per Rule 60 of the CBSE Examination Bye-Laws.

With this notice, these candidates are directed to show cause that why not their candidature be cancelled and action be initiated against them as per rules for submitting fake certificate. All candidates are directed to submit their reply in the concerned Regional Office with all supporting documents within 07 days from the date of the notice i.e. latest by 21.05.2024 failing which their candidature will be cancelled. The Board shall not be liable for any loss / damage caused to such candidates.
