The 2nd Expression Series for the academic session 2024-25 will be organized by CBSE on the theme Yuva Shakti for Viksit Bharat. The topics for each category are given as under:

Primary (Class 3 to 5)	Paragraph (150 words) / Painting	 My dream job when I grow up. What can I do to protect the environment?
Middle (Class 6 to 8)	Essay (400 words) / Painting/ Poem	 What does the rupee suggest for its effective utilization? Staying safe in the cyber world means staying safe in the real world.
Secondary (Class 9 to 10)	Essay (700 words) / Painting / Poem	 There is no right time for being financially literate. Use of social media as a learning tool.
Senior Secondary (Class 11 to 12)	Essay (1000 words) / Painting / Poem	 The new entrepreneurial idea for my village/town. What new things do I wish Bharat to have in 2047?

Conduct of Expression Series:

A. Conduct at the School Level:

i. Schools shall organize the school-level Expression Series during school hours on the above topics from 07 October 2024 to 21 October 2024. Information on the conduct of the Expression Series should be given to all students.

- ii. For participation in Expression Series activities, i.e. Essays/ Paragraphs/Paintings/Poems, etc., please use the format given in Annexure I.
- iii. Paragraph / Essay can be written in Hindi or English.
- iv. Schools shall complete the evaluation of entries and shortlist one entry per class category (a total of 04 entries from a school) for onward submission to CBSE.
- v. Entries must be supported by a Certificate from the Head of the Institution/ Teacher in charge that the entry is the original work of the participant.

B. Submission of the Shortlisted Entry by Schools to CBSE:

- Schools can submit/upload entries from 21 October 2024 to 28
 October 2024 using an Android phone through the CBSE
 Expression Series App available at the Google Play store. For guidelines on the process of submission, please see <u>Annexure II.</u>
- ii. Each participant will get an online certificate of participation at the registered e-mail ID after the successful submission of entry on the CBSE Expression Series App.
- iii. The 10 best entries of each category will be selected by each CBSE Region for selection of winners at the National Level.
- iv. The three best entries will be selected at the National Level.
- v. 10 best entries at the Regional Level (170 entries from 17 ROs) and 03 best entries at the National Level will be given an online certificate of merit by the Board.

The decision of the evaluation committee shall be final and no correspondence will be entertained in this regard.


Guidelines for Entry Submission by School

Expression Series Android App Usage Details: -


Requirement: Android smart phone having operating system version 5.0 and above with internet connectivity.
