This opportunity is being provided for all those candidates who have applied as a fresh candidate for the JEE (Main) – 2025 Session-2 (as well as for those candidates who had applied for JEE (Main) 2025 Session-1 and also registered for JEE (Main) 2025 Session-2).

All the registered candidates for the said Examination are advised to visit the website (<https://jeemain.nta.nic.in/>) and verify their particulars. They are further advised to make correction/s in their particulars, in their respective Application Form, if required.

The candidates are allowed to make the corrections, latest by **28 February 2025 (up to 11:50 P.M.)**. Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through Credit/Debit Card/Net Banking/UPI.

Since it is a one-time facility extended to the candidates to avoid any hardship, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.
