Subject: - Amendments in Affiliation Bye-Laws, 2018 under Chapter 11 & 12.

As per the recommendation of the Governing Body in its Meeting held on 26.12.2024 vide Agenda Item XVI and subsequent approval of the Controlling Authority of the Board, the following amendments in the Affiliation Bye Laws are hereby notified:-

A. Under Chapter 12 of Affiliation Bve- Laws- 2018:-

Existing Clause	Amended Clause
(a) 12.1.2: Imposing fine upto Rs. 5,00,000/-	12.1.2: - Imposing financial penalty as a deterrence. The quantum of financial penalty shall be decided on the basis of gravity of violations.

The following clauses are included under Chapter 11 & 12 of B. Affiliation Bye-Laws -2018 of the Board.

- 11.7.16:- It shall be the responsibility of the school to provide all assistance to Inspection Committee members to enable smooth conduct of inspection and shall produce any document, witness or records as called by the Inspection Committee members during inspection and provide unfettered access to school, building and infrastructure to the Inspection Committee members.
- 12.2.17: For creating any hindrance or obstruction by the school during conduct of Inspection by the Board.
