Subject: Declaration of Final Result of Combined Higher Secondary (10+2) Level Examination, 2024 - regarding.

The Notice for Combined Higher Secondary (10+2) Level Examination, 2024 was issued by the Commission on 08.04.2024 on its website. The Commission conducted Tier-I of the examination from 01.07.2024 to 11.07.2024. The result of Tier-I for shortlisting candidates to appear in Tier-II was declared by the Commission on 06.09.2024 wherein 39835 unique candidates were shortlisted for Tier-II.

2. Tier-II examination was conducted on 18.11.2024. Thereafter, as per the Important Notice No. F. No. HQ-PPII010/1/2024-PP_II dated 04.02.2025 published on the website of the Commission, Option cum preference has been taken online from the candidates who appeared in Tier-II of CHSLE 2024 from 04.02.2025 to 10.02.2025. A total of 27,092 candidates who have submitted their preferences online have been considered for further selection process.

3. As per the Para 17.7 of the Notice of Examination, Section-III, Module-I i.e. Computer Knowledge Test (CKT) and Module-II i.e. Data Entry Speed Test (DEST)/ Typing Test are of qualifying nature.

4. As per Para 17.1 of the Notice of the Examination, minimum qualifying marks in Section-I, Section-II & Module-I of Section-III of Tier-II Examination are as follows: -

- i. UR : 30%
- ii. OBC/ EWS : 25%
- iii. All other categories : 20%

5. As per the Para 17.10 of the notice of the examination, merit list has been prepared on the basis of aggregate marks scored in Section-I & Section-II of Tier-II examination subject to qualifying Section-III (both module). The Commission has fixed cut off marks in Module I and Module II as under :-

(i) Category-wise cut-off in Module-I of Section III (i.e. CKT) is as follows:

6. Resolution of Tie Cases: As per Para 18 of the Notice of the Examination, in the event of tie in scores of candidates in Tier-II examination, merit has been decided by applying following criteria, one after another in the given order, till the tie is resolved:

(a) Marks scored in Section-I of Tier-II Examination.

(b) Marks scored in Section-II of Tier-II Examination.

(c) Date of birth, with older candidates placed higher

7. As per the provisions of the Notice of Examination, allocation of posts to eligible candidates has been made on the basis of merit-cum-preference of posts submitted by the candidates online. Merit list has been prepared on the basis of overall performance of the candidates in Tier II examination only. 16 vacancies for the post of LDC/JSA in the Ministry of External Affairs (Post Code L19) as per the Final Vacancies of CHSLE 2024 uploaded on the website of the Commission on 04.02.2025 have been withdrawn by the User Department. Accordingly, these vacancies have not been considered by the Commission for allocation of the candidates in the Final Result. Subject to their qualifying in the document verification to be conducted by the respective user departments, a total of 3421 candidates have been provisionally recommended for appointment. Category-wise breakup of finally selected candidates is as follows:

In cases where candidates are selected against horizontal categories (i.e. 3-ESM, 4-OH, 5-HH, 7-VH and 8-PwD-Others) marks and Date of Birth of such last selected candidates are reflected against their respective horizontal category, not against their vertical category (i.e. 0-EWS, 1- SC, 2-ST, 6-OBC and 9-UR). In addition to this, vacancies of horizontal categories are also counted in their respective vertical categories as well.
