**Abbreviations stand for:**

SC - Scheduled Caste, ST - Scheduled Tribe, OBC - Other Backward Classes, EWS- Economically Weaker Section, GEN - General/Unreserved Category, PWD - Persons with Disabilities/ Persons with Benchmark Disabilities, OC / VI / HI / ID - As mentioned in para B.IV below.

**B. ELIGIBILITY CRITERIA (as on 01.01.2025)**

Candidates, intending to apply for above training seats should ensure that they fulfil the minimum eligibility criteria specified by Bank:

Please note that the eligibility criteria specified herein are the basic criteria for applying for the training seats. Candidates must necessarily produce the relevant documents pertaining to category, nationality, age, educational qualifications etc. in original along with a photocopy thereof in support of their identity and eligibility as indicated in this notification at the time of interview and any subsequent stage of the engagement process as required by the Bank. Please note that no change of category as well as any other details will be permitted at any stage after registration on the apprenticeship portal. Merely applying / appearing in the processes does not imply that a candidate will necessarily be offered apprenticeship. No request for considering the candidature under any category other than the one in which one has applied will be entertained.

**I. Nationality / Citizenship:**

A candidate must be a citizen of India.

**II. Age and Educational Qualification (As on 01.01.2025):**

Age: Minimum : 20 years  
Maximum : 28 years

The candidate must have been born not earlier than 02.01.1997 and not later than 01.01.2005 (both days inclusive)

**Educational Qualification:**

The candidate must possess a graduate degree in any discipline from a recognized university or any equivalent qualifications recognized by central government. The candidate should have passed his/her graduation degree between 01.04.2021 and 01.01.2025.

- (i) The maximum age limit specified in (II) above is applicable to General Category and EWS candidates.
- (ii) Candidates seeking age relaxation will be required to produce the original and have to submit copies of necessary certificate(s) at any subsequent stage of the engagement process as required by Bank.

Bank has right to post apprentices in any Branch/offices within the state from which he/she belongs to as per Bank's operational requirements.

#### **V. Reservation for Persons with Benchmark Disabilities**

Under section 34 of "The Rights of Persons with Disabilities Act, 2016", persons with benchmark disabilities are eligible for Reservation. The training seats are identified suitable for the Persons under categories of disabilities as defined in the Schedule of RPWD Act 2016 and notified by the Department of Empowerment of Persons with Disabilities (Divyangjan) from time to time.

#### **A. Orthopedically Challenged ("OC" category):**

A person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both, including Cerebral Palsy, Leprosy Cured, Dwarfism, Muscular Dystrophy and Acid Attack Victims. Orthopedically challenged persons are covered under locomotor disability with following bench mark:

- a. "Leprosy cured person" means a person who has been cured of leprosy but is suffering from:
  - i. Loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
  - ii. Manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
  - iii. extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall be construed accordingly;
- b. "Cerebral palsy" means a Group of non-progressive neurological conditions affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
- c. "Dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimetres) or less;
- d. "Muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they

need for healthy muscles. It is characterised by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;

e. "Acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

**B. Visual Impairment ("VI" Category)** : Only those Visually Impaired (VI) persons who suffer from any one of the following conditions, after best correction, are eligible to apply.

a. Blindness:

i. Total absence of sight; OR

ii. Visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; OR

iii. Limitation of the field of vision subtending an angle of less than 10 degree. OR

b. Low Vision:

i. Visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; OR

ii. Limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

**C. Hearing Impaired ("HI" Category):**

a. Deaf: means person having 70 DB hearing loss in speech frequencies in both ears.

b. Hard of Hearing: means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears.

**D. Intellectual Disability ("ID" Category):** Only those persons, who suffer from any one of the following types of disabilities, are eligible to apply under this category:

1. Intellectual disability.

a. Autism Spectrum disorder (ASD) means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

b. "Specific Learning Disability" (SLD) means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia.

c. "Mental Illness" (MI) means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognise reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterised by sub normality of intelligence

2. "Multiple Disabilities" means multiple disabilities amongst clause "A"; "B"; "C"; "D (1)".

**Note:** Only those persons with benchmark disabilities would be eligible for reservation. "Benchmark disability" means a person with not less than 40% of a specified disability where specified disability has not been defined in measurable terms and includes the persons with

disability, where disability has been defined in a measurable terms, as certified by the certifying authority.

A person who wants to avail benefit of reservation will have to submit a disability certificate issued by a Competent Authority as per Government of India guidelines. Such certificate will be subject to verification/ re-verification as may be decided by the competent authority.

#### (i) Guidelines for Persons with Benchmark Disabilities using a Scribe

The visually impaired candidates and candidates whose writing speed is adversely affected permanently for any reason can use their own scribe at their cost during the online examination. In all such cases where a scribe is used, the following rules will apply:

- The candidate will have to arrange his / her own scribe at his/her own cost.
- The scribe should be from an academic stream different from that stipulated for the post.
- Both the candidate as well as scribe will have to give a suitable undertaking confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe mentioned above. Further in case it later transpires that he/she did not fulfil any laid down eligibility criteria or suppressed material facts the candidature of the applicant will stand cancelled, irrespective of the result of this engagement.
- Those candidates who use a scribe shall be eligible for compensatory time of 20 minutes or otherwise advised for every hour of the examination.
- The scribe arranged by the candidate should not be a candidate for the online examination under this Engagement Project 2024-25/04. If violation of the above is detected at any stage of the process, candidature of both the candidate and the scribe will be cancelled. Candidates eligible for and who wish to use the services of a scribe in the examination should invariably carefully indicate the same in the online application form. Any subsequent request may not be favourably entertained.
- Only candidates registered for compensatory time (at the time of online registration) will be allowed such concessions since compensatory time given to candidates shall be system based, it shall not be possible for the test conducting agency to allow such time if he / she is not registered for the same. Candidates not registered for compensatory time shall not be allowed such concessions.
- During the exam, at any stage, if it is found that scribe is independently answering the questions, the exam session will be terminated and candidate's candidature will be cancelled. The candidature of such candidates using the services of a scribe will also be cancelled if it is reported after the examination by the test proctor / administrator that the scribe independently answered the questions. In such cases, the Candidate and scribe may also be debarred from all bank examinations for two years.

#### **(ii) Guidelines for candidates with locomotor disability and cerebral palsy**

A Compensatory time of twenty minutes per hour or otherwise advised shall be permitted for the candidates with locomotor disability and cerebral palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40% impairment).

#### **(iii) Guidelines for Visually Impaired candidates**

- Visually Impaired candidates (who suffer from not less than 40% of disability) may opt to view the contents of the test in magnified font and all such candidates will be

eligible for compensatory time of 20 minutes for every hour or otherwise advised of examination.

- The facility of viewing the contents of the test in magnifying font will not be available to Visually Impaired candidates who use the services of a Scribe for the examination.

#### **(iv) Guidelines for Candidates with Intellectual Disability (ID)**

A Compensatory time of twenty minutes per hour of examination, either availing the services of a scribe or not, shall be permitted to the candidates with more than 40% Intellectual Disability (autism, intellectual disability, specific learning disability and mental illness).

**These guidelines are subject to change in terms of GOI guidelines/ clarifications, if any, from time to time.**

#### **C. EWS (Economically Weaker Section)**

1. Persons who are not covered under the existing scheme of reservations to the Scheduled Castes, the Schedule Tribes and the Other Backward Classes and whose family has gross annual income below Rs.8.00 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWSs, irrespective of the family income:
  - i.) 5 acres of Agricultural Land and above;
  - ii.) Residential flat of 1000 sq. ft. and above;
  - iii.) Residential plot of 100 sq. yards and above in notified municipalities;
  - iv.) Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
2. The property held by a "Family" in different locations or different places / cities would be clubbed while applying the land or property holding test to determine EWS status.
3. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the Authorities as notified by the Government of India in the prescribed format shall only be accepted as proof of candidate's claim as belonging to EWS. The candidates shortlisted for document verification/interview shall be required to bring the requisite certificate as specified by the Government of India at the time of appearing for the process of document verification/interview.
4. The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.
5. The instructions issued by the Government of India in this regard from time to time shall be adhered to.

**Disclaimer: EWS Vacancies are tentative and subject to further directives of Government of India and outcome of any litigation.**

#### **D. SELECTION PROCEDURE:**

Selection for engagement of apprentices would be based on the basis of **(i) online written test and (ii) test of local language**

##### **I. ONLINE EXAMINATION:**

The structure of online examination will be as under:

Bank reserves the right to modify the structure of the examination which will be intimated through its official website.

The Total duration of examination would be 90 minutes.

The above tests except the Test of English Language will be available bilingually, i.e. English and Hindi. The test of English Language will be of qualifying nature i.e. Marks obtained in English Language will not be added while preparing merit List. The minimum qualifying marks in English, General/ Financial awareness, Quantitative & Reasoning Aptitude and Computer Knowledge will be decided by Bank at its sole discretion.

Qualifying marks stipulated above are for General/EWS Category candidates. Candidates belonging to the Category SC/ST/OBC/PWD, filling in vacancies reserved for the relevant category, will be entitled to a relaxation of 5% marks in relation to that stipulated for general category candidates.

##### **II. TEST OF LOCAL LANGUAGE**

The candidate applying for vacancies of a particular state, should be proficient (reading, writing, speaking and understanding) in any one of the local languages of that state (to be specified at the time of calling the applications). The test of local language will be conducted after qualifying the online written examination. Candidates who fail to qualify this test will not be engaged for apprenticeship. Candidates who produce 10<sup>th</sup> or 12<sup>th</sup> standard mark sheet/certificate evidencing having studied the specified opted local language will not be required to undergo the language test.



### III. STIPEND/ BENEFIT:

The apprentices are eligible for stipend of Rs.12000/- \* (Rupees Twelve Thousand Only) per month for the engagement period of one year. The apprentices are not eligible for any other allowances/benefits.

\*including subsidy amount if any, by Government of India. Bank will make payment as detailed below

The above stipend will be credited in the Saving Bank Account of apprentices each month after adjusting unauthorised leaves if any. Government share of Rs. 4500/- will be directly credited to the apprentices DBT enabled Bank Account registered with NATS Portals through Direct Beneficiary Transfer(DBT) mode as per extent guidelines.

### IV. Engagement type:

Apprentice. This is neither an employment in the Bank nor a contract employment in the Bank. Please note that the candidates engaged as Apprentices will only be a "Trainee" and will NOT be treated as "employees/worker" of Bank of India and will not be entitled to receive any benefits which are available for the Regular employees of the Bank or for the Contractual employees of the Bank. The provision of any law with respect to labour shall not apply to or in relation to such apprentice.

### V. Period of engagement:

Period of engagement shall be restricted to **one-year apprenticeship training programme** as per the provisions of the Act. Apprenticeship period shall not give the apprentice any lien/ right on permanent employment and consequential benefits with the Bank. Bank may also issue certificate to candidate upon the successful completion of Apprenticeship.

### VI. Assessment and Joint Certification:

Successful Apprentice, will be issued a proficiency certificate by Board of Apprentice Training (BOAT) and the Certificate will be uploaded on the NATS portal. The certificate will be available on portal based on rules and regulation of BOAT as declared time to time.

### VII. Final Selection:

Final selection of the candidates for apprenticeship will be subject to meeting the cut-off marks in the online examination to be decided by the bank, satisfactory verification of the documents/ information furnished in the online application at the time of pre-engagement formalities, qualifying the test of local language of the state and candidate being found medically fit. Merit List shall be drawn state wise and category wise. Candidates qualified in the test are to be placed according to their marks obtained in online examination in descending order in respective States and Categories.

If the marks obtained in the online exam are equal, then the merit order will be on the basis of Date of Birth i.e. Candidate senior by age will be placed higher in the merit List.

## List of Documents to be produced at the time of document verification:

The following documents in original together with a self-attested photocopies in support of the Candidate's eligibility and identity are to be invariably submitted at the time of document verification **failing which the candidate shall not be considered for engagement as an apprentice:**

- (i) Printout of the valid intimation letter issued by BFSI SSC.
- (ii) Proof of Date of Birth (SSC Marksheet)
- (iii) Photo Identify Proof (Aadhar Card)
- (iv) Mark sheets & certificates for educational qualifications. Proper document from Board /University for having declared the result between 01.04.2021 to 01.01.2025 has to be submitted.
- (v) Caste Certificate issued by competent authority in the prescribed format as stipulated by Government of India in case of SC / ST / OBC category candidates. In case of candidates belonging to OBC category, certificate should specifically contain a clause that the candidate does not belong to creamy layer section excluded from the benefits of reservation for Other Backward Classes in Civil post & services under Government of India. **OBC caste certificate containing the 'Non-creamy layer' clause should be issued** on or after 01.04.2024. **Caste Name mentioned in certificate should tally letter by letter with Central Government list / notification.** Candidates belonging to OBC category but coming under creamy layer are not entitled to OBC reservation. They should indicate their category as General in the online application form.
- (vi) Income and Asset Certificate issued by any one of the Authorities as notified by the Government of India in the prescribed format in case of EWS category candidates.  
Benefit of reservation under EWS category can be availed upon production of an 'Income and Asset Certificate' issued by a Competent Authority on the format prescribed by Government of India for the relevant financial year. The Income & Asset Certificate should be based on income of Financial Year 2023-24.
- (vii) Disability Certificate in prescribed format in case of PWBD category. If the candidate desires to use the services of a Scribe at the time of online examination, a detail Bio data of the scribe giving Scribe's: Name, Gender, DOB, Educational Qualification, Relationship with the Candidate, ID Proof No. and ID Proof Copy has to be submitted to BFSI SSC via email only, from the registered email id of the candidate to [info@bfsissc.com](mailto:info@bfsissc.com) within 48 Hrs of payment of the online examination fee with email subject line mentioned as **"SCRIBE BIODATA"**.
- (xi) Any other relevant documents in support of eligibility.

The Competent Authority for the issue of the certificate to SC / ST / OBC / Economically Weaker Section / PERSONS WITH BENCHMARK DISABILITIES is as under (as notified by GOI from time to time):

For Scheduled Castes / Scheduled Tribes / Other Backward Classes: (i) District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner / Deputy Collector / First Class Stipendiary Magistrate / City Magistrate / Sub-Divisional Magistrate (not below the rank of First Class Stipendiary Magistrate) / Taluk Magistrate / Executive Magistrate / Extra Assistant Commissioner (ii) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate (iii) Revenue Officer not below the rank of Tehsildar (iv) Sub-divisional officer of the Area where the candidate and/or his family normally resides.

Economically Weaker Section :(i) District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner, (ii) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate, (iii) Revenue Officer not below the rank of Tehsildar and (iv) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

For Persons with Benchmark Disabilities: Authorised certifying authority will be the Medical Board at the District level consisting of Chief Medical Officer, Sub-Divisional Medical Officer in the District and an Orthopaedic / Ophthalmic / ENT Surgeon or any person designated as certifying authority by appropriate government.

Candidates belonging to SC, ST, OBC, EWS, PWD categories have to submit certificates in support of it at the time of interview.

Prescribed Formats of SC, ST, OBC, EWS, PWD certificates to be submitted at the time of interview are available at the end of the Notice. Candidates belonging to these categories are required to produce the certificates strictly in these formats only.

## E. HOW TO APPLY

- I. All applicants will have to apply online for “**Apprenticeship with Bank of India**” from **01.03.2025 to 15.03.2025** by clicking the link <https://nats.education.gov.in> (the **apprenticeship portal**).
