DISPLAY OF PROVISIONAL ANSWER KEYS, AND QUESTION PAPER WITH RECORDED RESPONSES FOR ANSWER KEY CHALLENGE FOR JOINT CSIR-UGC NET EXAMINATION DECEMBER, 2024

The National Testing Agency (NTA) conducted the Joint Central Scientific & Industrial Research–University Grants Commission National Eligibility Test (JOINT CSIR-UGC NET DECEMBER, 2024) on 28th February and 01 & 02nd March, 2025 in 326 examination Centers located in 164 Cities across the Country for 2,38,451 candidates in the Computer Based Test (CBT) mode.

The National Testing Agency has uploaded the Provisional Answer Keys alongwith the Question Papers with Recorded Responses on the website <https://csirnet.nta.ac.in/> for inviting challenges (if any) to the Provisional Answer Key of any question ONLINE only. The procedure for the challenge of the Answer Key is enclosed at **Annexure-I**.

Candidates, who are not satisfied with the Answer Key, may challenge the same by paying a fee of ₹200/- (**Rupees Two Hundred only**) per question challenged as a non-refundable processing fee. The details for Answer Key Challenge are given below:

The payment of the processing fee may be paid through Credit Card/Debit Card/Net Banking/UPI Payment Modes till 14.03.2025 (upto 11:50pm). No challenge will be entertained without receipt of the processing fee. The fee towards the challenge will not be accepted through any other mode. The challenges will not be entertained through any other mode other than the online.

Challenges made by the candidates will be verified by a panel of Subject Experts. If the challenge of any candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly. Based on the revised Final Answer Key, the result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. The Key finalized by the Experts after the challenge will be final.

1. Please go to NTA website <https://csirnet.nta.ac.in>.
2. Click 'Challenge (s) regarding Answer Key'
3. Login with your **Application Number and Date of Birth** and enter the **security pin** as displayed and submit.
4. Click on "**View Answer Sheet**" for marked responses and to view or challenge the Answer keys, click on the link **Click "Challenge"** button to view provisional answer keys and challenge the questions.
5. **You will see Question IDs in sequential order.**
