Subject: Timely Conduct of Exams and Issuance of Academic Awards to Students by Higher Education Institutions-reg.

आदरणीय महोदय/महोदय,

It has come to the attention of the University Grants Commission (UGC) that certain Higher Education Institutions (HEIs) are not conducting exams on time and/or delaying the issuance of degrees and final certificates to students. This delay causes a loss of opportunities for students as it prevents them from securing suitable and quality employment. It also hampers the students' further academic prospects.

It is pointed out that Clause 4.4 of the University Grants Commission (Grant of degrees and other awards by Universities) Regulations, 2008, provides that "the Degree award date/s shall be within 180 days of the date/s by which the students are expected to qualify and become eligible for them".

Similarly, Clause 2.6 of the UGC Guidelines for Students' Entitlement, 2012, provides that "the students are entitled to timely conduct of examination and declaration of results as specified in the academic calendar in the Prospectus. They shall be entitled to the award of degree within 180 days of the declaration of results".

The Commission has the power to take punitive action in case of non-compliance.

It is relevant to mention that the UGC has also issued a Public Notice on 19.06.2024 on this matter. A copy of the same is attached herewith.

In this regard, all HEIs are, therefore, once again urged to comply with provisions of the said Regulations and Guidelines and ensure the timely administration of examinations and the prompt issuance of final academic awards to students.


